JOB OUTLOOK

29 Palms Marine base — Xcel Mechanical -Barracks remodel is getting started week, of 6/23/25 they have started calling out apprentices for that start date.

Mountains Community Hospital (M.C.H.) ACCO-October for make ready. Should start construction in January.

1-40 Rest Area — ACCO — Underground work has begun. Should finish in 3 to 4 weeks. There will be a month of down time then ramp back up. Should need at least one more fitter and apprentice in August.

Morongo Health Clinic, ACCO Underground starting at end of June. Will transfer 364 hands and call an additional apprentice if needed. COTD project, ACCO month of underground left, 4-6 months off while building goes up. Eisenhower Medical Center — Western Allied — Will be doing a three-story Medical Office Building in June and should be needing 8-10 Pipefitters.

ACCO is chasing a lot of work in Morongo Schools in Coachella Valley, and in Temecula.

Verne's Plumbing- Moreno Valley USD, may need 1 or 2 Plumbers this month.

Vernes Plumbing- San Bernardino Animal Care Center, Will need 2 Plumber Journeyman also this month.

Pan Pacific- Lorna Linda, Lorna Linda Children's Center Outpatient Pavilion. Pan Has Plumbing and Pipefitting and will run a crew of 21, 10 Pipefitters, 1 Welder, and 10 Plumbers. Plumbers will begin to ramp up July 14th. It is not yet clear how many 364 hands they will transfer from other jobs vs how many will come off of the list.

Control Air- Beaumont, Beaumont Library. Will run a crew of 6 Plumbers.
